

# DA VINCI TALKS TERMS AND CONDITIONS

## 1. REGISTRATION FEES

The Da Vinci Talks include 3 Talks: the Leonardo Talk, the Notre Dame Talk and the Renaissance Talk.

The Leonardo Talk, the Notre Dame Talk and the Renaissance Talk have the same fees and concessions:

- The fee for an adult is 55 AUD\*
- The fee for a senior\*\* is 45 AUD\*
- The fee for a student\*\*\* is 35 AUD\*
- The fee for an adult accompanied by a child\*\*\*\* is 60 AUD\*
- The fee for a 3 Night Ticket Bundle is 135 AUD\*

\* Prices include GST but do not include Eventopia service fee.

\*\* Seniors will be asked to show a concession card upon admission:

- Seniors Card (all states)
- Australian Government Pension Card
- Identity Card for International seniors aged over 60 years

\*\*\* Students will be asked to show a concession card upon admission:

- Australian Student Card
- International Student Card

\*\*\*\* Children under the age of 18 will be asked to show an identity card upon admission.

Participants are advised to have a copy of their payment slip or invoice when going to the admission desk at the Talks just in case they are requested to show proof of the payment on their arrival.

## 2. CHANGES & CANCELLATION POLICY

Each Ticket is nominative. Agenda Pacific has discretion in the replacement of Tickets and reserves the right to charge a fee for the replacement of Tickets.

Except to the extent required by law, or to comply with the Ticketing Code of Practice published by Live Performance Australia (the TCP), Agenda Pacific will not refund any Ticket, whether or not there has been a variation to the Da Vinci Talks, or you are evicted from or refused entry to the Da Vinci Talks in accordance with the Da Vinci Talks Terms and Conditions.

If the Da Vinci Talks are cancelled for any reason, refunds may be processed, other than as required by law or the TCP, at Agenda Pacific's discretion.
